NOTICE OF PERMIT HEARING & REGULAR MEETING

The Plateau UWC&SD Board of Directors will hold a permit hearing & regular meeting on Wednesday, October 22, 2025 at 12:30 p.m. at the Schleicher County Annex Bldg., 203 SE Main St, Eldorado, Texas.

Permit Hearing – 12:30 p.m.

Permit Application – Peyton Schaefer – proposed new well at 30 degrees, 50 minutes, 29 seconds North & longitude 100 degrees, 51 minutes, 39 seconds West; not to exceed 60 acre feet production of groundwater annually; irrigation.

Permit Application – Bob Buchholz – Proposed production (existing well) at 30 degrees, 51 minutes, 26 seconds North and longitude of 100 degrees, 34 minutes, 07 seconds West; not to exceed 250 acre feet production of groundwater annually; irrigation.

Permit Application – Cory Lloyd – proposed new well at latitude 30 degrees, 52 minutes, 26 North and longitude 100 degrees, 43 minutes, 48 seconds West; not to exceed 250 acre-feet production of groundwater annually; irrigation.
